Adoption of the Mayor and Board of Alderman Board Meeting Minutes of November 27, 2023 Alderman Alethea Harris made a motion to adopt the Mayor and Board of Alderman Meeting Minutes of November 27, 2023, and the motion was 2nd by Alderman Chastain: vote passed 4-0

Adoption of the Finance Committee Meeting Minutes of December 14, 2023 Vice Mayor Catron made a motion to adopt the Finance Committee Meeting Minutes of December 14, 2023, and the motion was 2nd by Alderman Harris: vote passed 4-0

Adoption of the Town of Mason Special Call Board Meeting Minutes of January 11, 2024 Alderman Harris made a motion to adopt the Town of Mason Special Call Board Meeting Minutes of January 11, 2024, and the motion was 2nd by Vice Mayor Catron: vote passed 4-0

Mayor Noeman Report: Mayor Noeman "Thanked" Alliance, the staff at City Hall, Mason Fire Department, Blue Oval, the Community, Churches, Richard Marbury, Daniel Rogers, and the Alderman of Mason for their assistance and support during the state of emergency with the water crisis. Mayor Noeman included Governor Lee, Senator Paul Rose, Ms. Courtney Fee, and the Comptrollers regarding the emergency water crisis.



Ms. Lureatha Harris read the report that was submitted by Mr. Perry with Alliance, regarding repairs that were going on to correct the problems with the busted pipes/water lines.

Mr. Ricky Oakley with CEC discussed the 2024 Engineering Schedule for \$1.954 million TDEC ARP Projects. Mr. Oakley expressed that emergency connection with Poplar Grove Utilities is very critical. Mr. Oakley will work with Alliance to make the system more successful.

OLD BUSINESS:

• Sanitation Contract – Justin Sanders

No performance bond/surety bond was provided by Mr. Sanders, as this was a request that was made prior by the Board of Alderman.

Mr. Jon Snyder, an Operations Manager with Waste-Pro was in attendance, and spoke about the sanitation service that's being provided on an expired contract with the Town. Mr. Snyder wanted to know where Waste-Pro stood in the process. The question arose as to what could be done differently with the service of Waste-Pro. Examples included drivers, technicians, and service for a better partnership.

Alderman Chastain made a motion to stick with Waste Pro, and the motion was 2nd by Alderman Rivers: vote passed 4-1 (Alderman Harris voted no)

• Town of Mason Retirement Plan Study

Mr. Tim Joyce explained the TCRS retirement plan study to Mayor Noeman and the Board. Plan 3 is what the Board looked at, and it is the most affordable plan. TCRS is 3% of payroll cost for full-time employees, and its optional. Moving forward, newly hired full-time employees will be required to join the plan. Benefits of TCRS, it provides benefits to current employees, and retention of employees. This would take effect April 1, 2024. Alderman Toliver made a motion to accept The TRCS Plan Resolution to take effect on April 1, 2024, and the motion was 2nd by Alderman Rivers: vote passed 5-0

NEW BUSINESS:

• Public Hearing Notice 2nd Reading of the Rezoning of a 44 Acre Parcel

Alderman Harris made a motion to not accept the 2nd Reading of the Rezoning of a 44 Acre Parcel, and the motion was 2nd by Alderman Chastain: vote passed 4-1 (Alderman Toliver voted no) Mr. Smith had concerns if there was a change in the neighborhood and if there was a need. Alderman Harris mentioned that a contingency could not be put on the property.

• Ethan Whitley – Report on Old Court House Building 12224 Main Street

Mr. Ethan Whitley, provided a layout for mixed use development for the property located at 12224 Main Street. Kevin & Wendy Rosser is interested in purchasing the property at the above address for \$35,000. Mayor Noeman and the Board would like to have Attorney Clayton review the information before accepting. Alderman Rivers made a motion to allow Attorney Clayton to review before accepting the offer, and the motion was 2nd by Alderman Toliver: vote passed 5-0

Attorney Clayton mentioned a lawsuit for property damage construction, regarding an auto accident at the entrance of the Richland Hills Subdivision. The policy limit of the owner is \$15,000, and that is the amount that the lawsuit was agreed for. Alderman Toliver made a motion to accept the \$15,000 dollar offer for the lawsuit, and the motion was 2nd by Alderman Harris: vote passed 5-0

The Judge will file a late filing of the appeal bond with Barnett Restoration. There was no response from the subpoena for the bankers. The FBI was contacted and pending investigation.

The claim on Mason Charleston Rd. is being handled by the insurance company

Alderman Harris made a motion to accept the Finance and Administration Department Report, and the motion was 2nd by Vice Mayor Catron: vote passed 3-2 (Alderman Rivers and Alderman Toliver voted no)

Tanner Jenkins, Fire Chief Alderman Chastain made a motion to accept the Fire Department Report, and the motion was 2nd by Alderman Toliver: (vote passed 5-0)

Parks & Public Works Department

Alliance Report was read by Lureatha Harris

Police Department

Chief Richard Jewell

Chief Jewell spoke about needing more officers and better pay, Mayor Noeman said he would try to work on it. Alderman Toliver made a motion to accept the Police Department Report, and the motion was 2nd by Alderman Harris: vote passed 5-0

Margaret Adams reported a leak on Cottontail Street in the middle that constantly runs, and Alliance knows about it. Mayor Noeman said he will jump on the problem.

Teresa McBride Burtis questioned getting monies for fixing leaks, and stating that the monies need to be used only for water repairs. Alderman Harris assured Mrs. Burtis that the money was approved for \$1.8 million, but the funds have not been received.

Cathy Johnson has concerns about potholes across the railroad tracks. Alderman Rivers suggested placing big rocks in the potholes. Mayor Noeman will work with Mr. Neill and his engineer to assist with a bid packet to advertise for street paving.
